



Background information

To help countries protect people from developing severe disease from pandemic influenza H1N1 infection, the World Health Organization (WHO) coordinated the distribution of donated pandemic influenza vaccine to eligible countries. This document is a final update on the efforts to mobilize resources, ensure a sufficient supply of prequalified vaccines, support country readiness and deploy vaccines and ancillary products to countries.

Mobilizing resources

Governments, foundations and manufacturers offered contributions of vaccines, ancillary products (such as syringes and safety boxes) and finances to support the donation initiative.

WHO received pledges of approximately 200 million doses of vaccine, 70 million syringes and US\$ 48 million for operations.

⁴ Additional auto disable syringes were procured to ensure that vaccines were distributed with sufficient ancillary equipment in support of injection safety policies and practices.

⁵ Additional sharps disposal/ safety boxes were procured to ensure sufficient supplies for safe sharps disposal.

⁶ The pledged resources were sufficient to deploy all pledged vaccines.

Preparing countries to receive vaccines

WHO and partners assisted all eligible countries in receiving and using vaccines. Before countries received donated vaccines, they completed three steps:

1. requested donated vaccines,
2. signed an agreement accepting the terms and conditions of support and
3. developed a national vaccine deployment plan.

Final overview

1. 97 countries requested vaccine donations
2. 87 countries signed agreements with WHO
3. 82 National Deployment Plans completed and final; 0 plans are being refined.
4. All vaccines have been delivered as requested by countries.

Prequalification of pandemic vaccines

WHO only supplied prequalified vaccines that were reviewed by a team of WHO experts and deemed to meet international quality standards. Nine pandemic influenza vaccines were prequalified. More information at:
