Improving Every Woman Every Child Alignment

In September 2017, a Task Team was set up to oversee the work on improving thematic, operational and/ or institutional alignment between core partners of the EWEC architecture. The Task Team oversees an independent consultancy process, to result in a paper to the PMNCH Board (December 2017)

- **Consultations:** Independent consultant Dr Peter Colenso is conducting consultations with a wide range of stakeholders, including countries, EWEC core partners (H6, GFF, PMNCH and EOSG), and PMNCH constituency groups.

September-November 2017

- **Survey input:** Cross-SO survey input from PMNCH SO members.

October 2017; 35 responses to date

- **Governance discussions:** Discussions within EWEC partner governance mechanisms, including PMNCH Executive Committee meetings

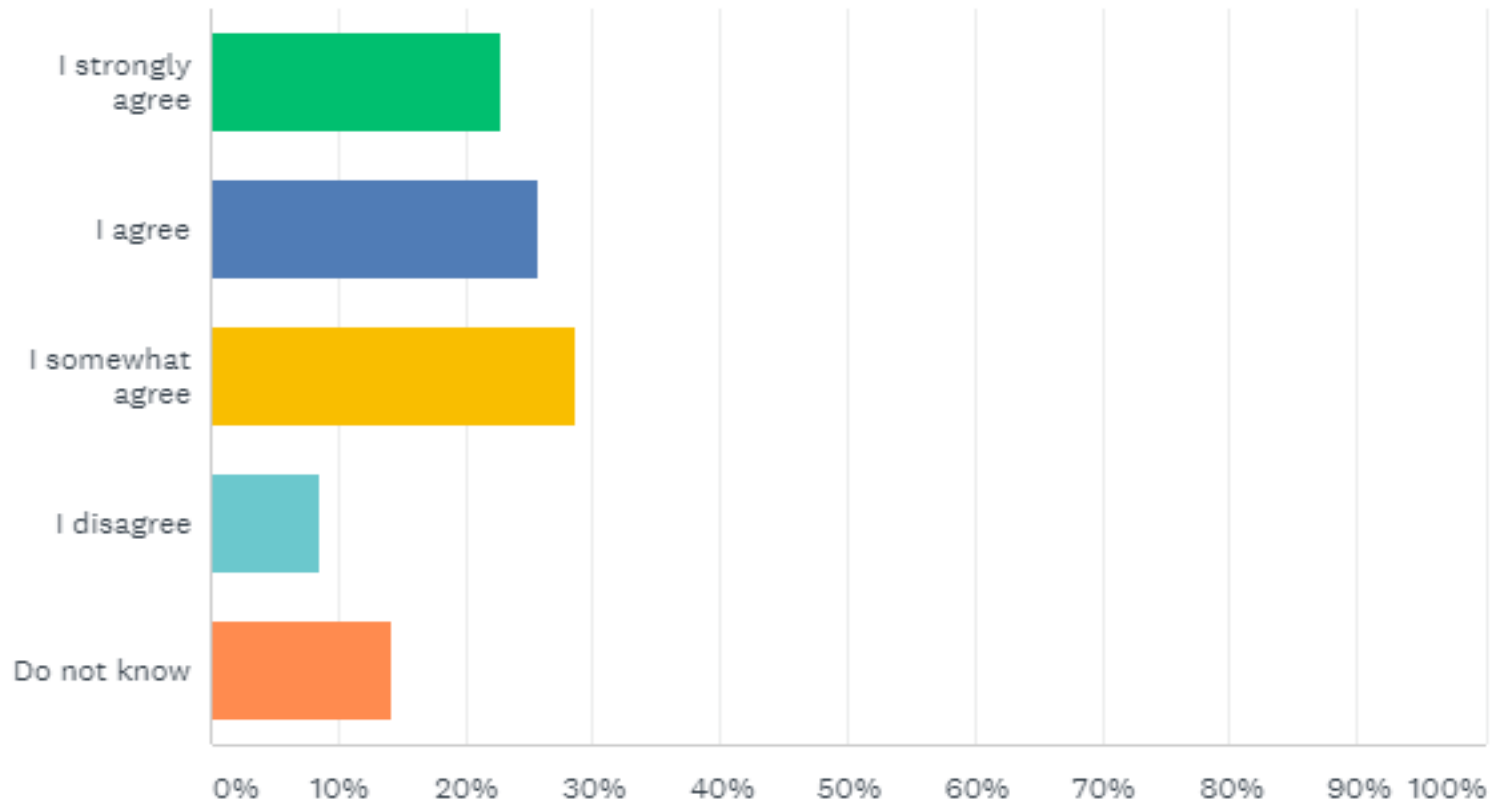

Cross-SO survey results on EWEC “merger”



- 35 respondents (2 Nov 2017)
- Most respondents agreed (“strongly” – “somewhat”) that a merger would be important to their work (27/35)

Key milestones for EWEC Task Team
